Mayor Zafft reported that snow piles are causing some water issues and that a better plan should be made for piling up the snow. Zeb and Jordan are busy getting caught up on projects. Jason Hanssen reported ENCC had a gain of \$50,398.40 for the month of March. The current census is at 56 and they have a waiting list. There was a good legislative session and a 25% increase will be coming in the Medicaid rate. Staffing is good at present. There have been no more cases of Covid. The new windows are being installed. Sherry Bjorklund was recently awarded the April Millie E. Olson award.

Cheryl Squires reported that a Healthy Hometown meeting was held. They are still working on completing the inventory in the library and also some improvements at the community gardens in the spring.

Zeb Gilbertson and Jordan Busch reported that well #3 was repaired by Thein Well Co., a new pump was installed at the lift station, Pipemasters came to jet some culverts. They are planning to check out each manhole this spring and also check hydrants for leaks.

New Business:

Jesse Saathoff and Jerry Runia, representing Estelline Township, asked if there might be some possible storage available in the city shop for a payloader/snow plow that they had purchased for the township. Mayor Zafft explained that presently the shop is full and we would have to move some of the city equipment out to make room for them, and this would not be feasible for the city.

Michaelle Gilbertson asked for some repairs at the concession stand. She stated that the door needs to open to the outside and not go inside, there is not enough electrical power, and there is a need for a window on the north side for more air circulation. Motion was made by J. Cokens, second by R. Brandsrud to switch the door, add additional breakers for electricity, and install a ceiling fan for circulation, not to exceed \$600-\$700 total. With all voting aye, motion carried.

Dean Skoglund gave an insurance update and the renewal for the 2023-2024 year. Motion was made by J. Rieckman, second by R.Miller to approve. With all voting aye, motion carried.

J. Hanssen presented a quote from Maxwell Food Equipment for an electric food slicer. Total cost is \$3019.20. Motion was made by J. Cokens, second by C. Squires to approve. With all voting aye, motion carried.

A quote from Direct Supply for Panacea 12 cell Air Mattresses for \$2770.00 was approved with a motion by R. Miller, second by R. Brandsrud. With all voting aye, motion carried.

A quote for a water bottle filling station was presented for \$1374.20. Motion by J. Cokens, second by J. Rieckman to approve. With all voting aye, motion carried.
